RE: Year 11 - Final Day

I am writing to outline some key information regarding your child's last day at George Salter Academy.

The final compulsory day for your child to formally attend George Salter Academy will be **Monday 16th June 2025**. On the morning of this day, all students will be sitting their GCSE Science exam, following which they will assemble in the Green Room. After the assembly, your child will have the opportunity to take photographs with friends, should they wish. At approximately 11.30am, once all formalities and goodbyes have taken place, we will ask your child to make their way safely home. We kindly ask students not to congregate outside of the school gates or in the local area.

Students may want to bring in a shirt to sign, we will allow this to take place after their leaver's assembly on Monday 16th June only. Please note it is against JCQ rules to have any written material in the examination hall; we will uphold this rule without exception.

There will be further examinations beyond Monday 16th June. If your child continues to attend the academy for these exams or revision sessions, they must be in full school uniform. Entrance will be via main reception; they will be required to sign in and out.

GCSE results will be available to collect from 9am on Thursday 21st August 2025. Please see the academy website for updates.

In the spirit of generosity, if your child no longer requires their school tie or blazer, we would be happy have them donated to us.


